Irina Bokova

Nació el 12 de julio de 1952 en Sofía Bulgaria; es una diplomática y política búlgara que desempeña el cargo de directora general de la UNESCO desde el 15 de noviembre de 2009, siendo la primera mujer elegida a la cabeza de la organización. Políglota (ruso, inglés, francés y español), fue ministra de relaciones exteriores y coordinadora de las relaciones de Bulgaria con la Unión Europea (1995-1997), y posteriormente embajadora de Bulgaria (2005-2009) en Francia, Mónaco y ante la UNESCO y representante personal del presidente de la República de Bulgaria ante la Organización Internacional de la Francofonía (OIF). En el transcurso de su carrera, representó asimismo a Bulgaria ante las Naciones Unidas.

Mauro Bussani

Is professor of Comparative Law at the University of Trieste, Scientific Director of the International Association of Legal Sciences (IALS - UNESCO), and Adjunct Professor, Faculty of Law, University of Macao, S.A.R. of the P.R. of China. He is co-editor of a Cambridge University Press series, and holds positions in the Scientific Council of many international institutions and law reviews. He has been visiting professor in the US, Brazil, Macao, Peru, France, Switzerland, UK, Portugal, Serbia, Hungary, China. His principal publications include 23 Books (of which 7 are simply edited), and more than 110 Essays, in Italian, English, French, Spanish, Portuguese, and Chinese.

Est directrice de recherches au CNRS et directrice du CECOJI (Centre de recherches sur la coopération juridique internationale). Is currently an Associate Professor at China University of Political Science and Law (CUPL), Deputy Director of the Institute of Private International Law of CUPL, member of the China Society of Law, and Associate Member of the Centre for Private International Law at the University of Aberdeen, United Kingdom. He is also serving as observer of the UNESCO

1970 Convention and legal expert for the State Administration of Cultural Heritage of China. Prof. Huo's principal areas of teaching and research include private international law, culture property law and comparative law and he has published extensively in these areas. He is a New Century Excellent Talents in University (NCET) Laureate, awarded by the Ministry of Education of China.

Is a Professor at the Faculty of Law, University of British Columbia. He is a member of the External Advisory Board of the University of British Columbia Muse-

um of Anthropology. Professor Paterson is the author of numerous articles and books on cultural heritage issues including most recently: *Protection of First Nations Cultural Heritage: Laws, Policy, and Reform* (with C. Bell, 2009) and *Cultural Law: International, Comparative, and Indigenous* (with J. Nafziger and A. Renteln, 2010).

Lyndel Prott

Former director of UNESCO's Division of Cultural Heritage and former Professor of Cultural Heritage Law at the University of Sydney, holds law degrees from Australia, Belgium and Germany. At UNESCO she was responsible for its Conventions and Recommendations on the protection of cultural heritage and for negotiations on three multinational treaties on cultural heritage. She has published 300 items (books, reports, chapters, articles and other) available in 12 languages. Currently Honorary Professor at the University of Queensland, she has taught at many universities around the world. She has been honored for her work in Cultural Heritage Law by Austria, Australia and by the American Institute of Archaeology.

Edouard Planche

Is a lawyer specialized in legal protection of cultural property and cultural heritage preservation. He is responsible at UNESCO for the implementation of the 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property. He also serves as Secretary of the Intergovernmental Committee for Promoting the Return of Cultural Property to its Countries of Origin or its Restitution in case of Illicit Appropriation.

Marc-André Renold

Professor of art and cultural heritage law at the University of Geneva, Holder of the UNESCO Chair in the International Law of the Protection of Cultural Heritage and the Director of Geneva Art-Law Centre. He studied at the Universities of Geneva and Basel in Switzerland and at Yale University in the USA. He is also Attorney-at-law, Member of the Geneva Bar and is of counsel to a major Swiss-German law firm.

Marc-André Renold has been Visiting Professor at the Faculté Jean Monnet of the University of Paris Sud (2006-2007) and at the University

of Lausanne (2008-2009). He has also lectured at The Hague Academy of International Law, at the University Jean Moulin in Lyon and the Graduate Institute of International Studies in Geneva.

He is the author or co-author of several publications in the field of international and comparative art and cultural heritage law and has been, since its inception, an editor of the “Studies in Art Law” series. He is the co-editor and co-author of *Culture, Art and Law: Swiss and International Law* (2009), the leading Swiss handbook written in German on the law of art and culture.
